

I just did not see any edge Friday. Price was trading nearly the range of Thrusday. With a 26 handle day it was just a tad over a nothing burger day. The pull back at 1:30 pm checks a higher high. As price closes somewhere around the open the day ends as it started.

P.S. If you've read this analysis, you might be curious when the best time to consider a position: (Sydneys / AI Read)

As a seasoned eMini futures trader, I would look for the best time to enter and exit a trade based on market analysis, technical indicators, and price action.

Based on your description, it seems that the market opened with a gap down and then hovered around the R2 level for most of the day, indicating a potential area of resistance. The fact that the Composite Man is not pressing suggests that there may not be strong buying interest at current levels.

In this situation, I would look for a potential short entry if price breaks below the R2 level with strong volume and momentum, indicating that sellers are gaining control. I'm just a regular guy; Not Silver spoon family or WALL Street / Chicago network or Financial Fast Track educational express super star golden boy, I have an Intimate knowledge of the insider mindset / how the insiders on Wall Street think act and position their trades.

I wrote my own charting program. I don't use indicators. Just judgment: interaction of Price, Volume and Time. I focus on the Intraday waves of the market and how they are timed to the "hidden clock" of the market. I look at the composite man the "insider" in terms of the market. Others look at bulls and bears (my strongest point)

I SEE THE MARKET IN TERMS OF THE COMPOSITE MAN / INSIDER – Most traders look at the market in terms of bulls and bears. This creates a dichotomy. A duality of the mind. Wyckofff looked at the market in terms of Composite Man / "insiders".

Actionable Trade Plan

I. Market analysis - Perhaps today or tomorrow the adults will start to enter back into the room and get price back down to wholesale level. I said tha yesterday and the did enter the room and started selling at these highs. Perpahs the saying was sell at the Summer Solsace and go away? Would like to see more defined ranges starting this week.

II. Overnight read - Over the weekend price traded back down to Friday's CASH low and found a bid. Currently trading in the upper range of Fridays' trade.

III. I have mixed emotions on giving levels and pivots. I'm looking at price, volume, and the interaction of price/volume/time. That does not show up in levels. We had such a good day yesterday, let's just let the chips fall where they fall and let price, volume, and the interaction of price/volume/time show us the way.

Traders are betting that price is overbought/overvalue but who knows when the top is in? You only know when it's not. When you know that, then jump on the train back down for the ride. Till then, train keep a rollin!

V Risk management: Use a risk-reward ratio of at least 1:2, and risk no more than 1% of your account on any single trade. Use a trailing stop loss to lock in profits as the market moves in your favor.



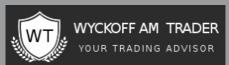
